#### **Fellowships and Scholarships**

Bernstein Litowitz Berger & Grossmann Public Interest Law Fellowship, Columbia Law School: This fellowship provides Columbia Law School graduates with full funding to cover their law school tuition loans as long as they remain in the public interest law field. This program enables young lawyers to pursue careers in public interest law without financial constraints.

**Paul M. Bernstein Memorial Scholarship, Columbia Law School**: Honoring our founding senior partner, Paul M. Bernstein, this scholarship at Columbia Law School supports second-year students who exhibit academic excellence, professional responsibility, financial need, and community involvement. Established in 1990, it continues to nurture the development of future legal leaders.

Dale and Max Berger Public Interest Law Fellowship at Columbia Law School: Established by BLB&G Founding Partner Max Berger and his wife, Dale, this <u>fellowship</u> nurtures the next generation of lawyers dedicated to public interest work, ensuring that talented individuals have the financial support needed to pursue careers that prioritize community service and the public good.
