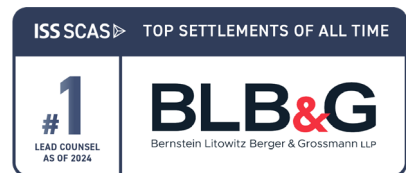

Our firm was ranked #1 for the 15th consecutive year in ISS SCAS's 2024 **Top 100 U.S. Class Action Settlements of All-Time** report. BLB&G was also recognized as

a leading plaintiffs' securities firm in ISS SCAS's **Top 50 Plaintiff Law Firms of 2024** report. These reports highlight key metrics that illustrate BLB&G's record of success for institutional investor plaintiffs:



- BLB&G served as lead or co-lead counsel in 37 of the top 100 securities fraud settlements—13 more than our nearest competitor.
- Of the settlements included, BLB&G has recovered more than \$27 billion for shareholders—\$7 billion more than any other firm. We have recovered more than \$40 billion overall.
