### **Keynote Speaker: Fredrik Reinfeldt**

Fredrik Reinfeldt served as Prime Minister of Sweden from 2006 - 2014. He reinvented the Moderate Party (center-right) and formed a four-party alliance that won two successive elections and helped Sweden overcome a significant financial crisis and recession. Mr. Reinfeldt personalized the Swedish “open door” migration policy during his tenure and acted as a rotating President of the European Council in 2009. After leaving politics in 2015, Mr. Reinfeldt was elected chair of the Extractive Industries Transparency Initiative – an international coalition of stakeholders working together to promote open and accountable management of natural resources. He will discuss the current geopolitical landscape and provide insight on recent developments relating to the challenges of the European Union, Brexit, and refugee migration among other topics.
