BLB&G Again Achieves Top Rankings for Securities Litigation and Delaware Chancery in *Chambers USA* 2025

Chambers USA has once again ranked BLB&G as the top firm in the nation for plaintiff-side securities litigation work in its 2025 guide.

BLB&G earned "Band 1" rankings for securities litigation in the Nationwide, New York, and California categories, as well as for plaintiff-side chancery work in Delaware. The firm has received top rankings for securities litigation every year since *Chambers* created the category to recognize a select number of firms performing plaintiff-side work.

Max Berger, ranked Band 1 in New York for Litigation: Securities: Plaintiffs, is noted by *Chambers* as having "secured some of the largest recoveries ever achieved in securities fraud lawsuits." The publication notes that Max "offers notable strength in high-stakes class action and derivative lawsuits."

Salvatore Graziano, ranked Band 1 in New York for Litigation: Securities: Plaintiffs, is described by quoted sources as "a dedicated and talented litigator and a leader in the firm who teaches by example."



Jim Harrod, ranked Band 3 in New York for Litigation: Securities: Plaintiffs, is a new addition to the *Chambers* guide. He is described by quoted sources as someone who "takes on difficult matters with outstanding scholarship and strategic skills."

John Rizio-Hamilton, ranked Band 3 in New York for Litigation: Securities: Plaintiffs, is also a new addition to the *Chambers* guide. He is described as "an experienced litigator who is often sought after to represent investor plaintiffs in large cases against companies in industries such as tech, logistics and finance."

Hannah Ross, ranked Band 2 in New York for Litigation: Securities: Plaintiffs, is recognized as "an experienced litigator with a considerable trial background." Sources note her unwavering dedication to her clients, saying, "She makes you feel like you are her only client and the main priority."

Jerry Silk, ranked Band 1 in New York for Litigation: Securities: Plaintiffs, is "recognized for his expertise in a range of cases on the plaintiff side...highly experienced in cases involving RMBS, as well as M&A litigation and accountants' liability cases." Quoted sources commend his "good sense, excellent people skills and an outstanding commitment to excellence."

Katie Sinderson, ranked Band 3 in New York for Litigation: Securities: Plaintiffs, is recognized by *Chambers* as "an experienced securities litigator with a strong track record assisting investors with securities fraud class actions."
